- ORGANISERS WILL ALLOT THE STALLS SPACE ONLY TO THE CONFIRMED EXHIBITORS i.e. WHO HAVE FURNISHED FULLY FILLED APPLICATION FORM ALONG WITH CHEQUE/DD.
- ORGANISERS WILL MAKE APPROPRIATE SECURITY ARRANGEMENTS. HOWEVER ORGANISERS WILL NOT BE RESPONSIBLE FOR ANY LOSS AND/OR DAMAGE TO DISPLAY MATERIAL, SAMPLES WHATSOEVER.
- THE SCHEDULE OF THE STALL SPACE POSSESSION WILL BE GIVEN TO THE EXHIBITOR AT THE TIME OF CONFIRMATION AND EXHIBITOR SHOULD STRICTLY ADHERE TO IT.
- EXHIBITOR WILL CARE FOR THE FLOORING, WALLS AND ANY OTHER STRUCTURES DURING STALL SPACE DECORATION AND ALSO WHILE BRINGING AND REMOVING THE MATERIALS.
- EXHIBITOR SHALL ENSURE THAT NO HAZARDOUS OR INFLAMMABLE MATERIALS ARE KEPT IN THE STALL SPACE AND SHALL ALSO ENSURE TO ADOPT ADEQUATE SAFETY MEASURES IN THIS REGARD.
- EXHIBITOR SHALL BEAR ALL THE COSTS FOR ANY DAMAGES CAUSED TO THE STRUCTURE ETC. DUE HIS NEGLIGENCE.
- EXHIBITORS SHALL ENSURE THAT ALL DEMONSTRATIONS, INTERVIEWS, ADVERTISING, PROMOTION AND OTHER SALES & MARKETING ACTIVITIES ARE CONDUCTED WITHIN THE STALL SPACE ALLOCATED.
- AUDIO/VIDEO DISPLAYS MAY BE CONDUCTED WITHIN THE STALL SPACE AT LOW VOLUME.
- IN THE EVENT OF CANCELLATIONS OF STALL SPACE BOOKING, ADVANCE PAYMENTS MADE TOWARDS THE SAME STAND FORFEITED.
- A REDUCTION IN BOOKED STALL SPACE AREA WILL ALSO BE TREATED AS CANCELLATION OF THE ENTIRE AREA STALL SPACE AREA BOOKED, AND ADVANCE PAYMENT MADE TOWARDS THE SAME WILL BE FORFEITED.
